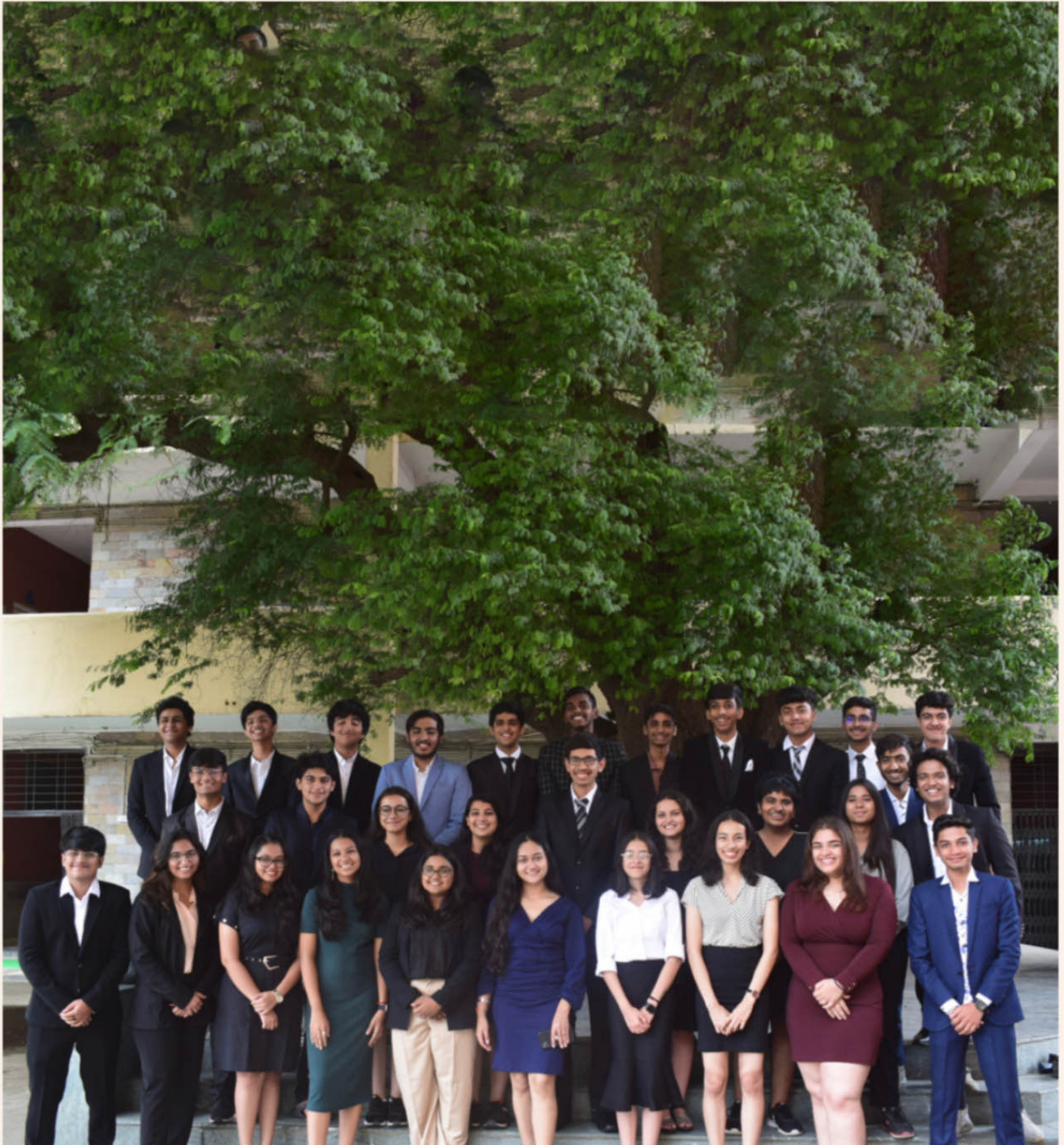

INTRODUCTION

Being true to its motto, 'Youth is You' the team plunged into the meticulous task of choosing the agendas that were relative to the young, curious minds of the youth across our country, who seek resolutions in a world with enumerable concerns of national, international and social interests. This idea gave rise to the theme of CENMUN 2022, 'Predicaments to panacea: a glocal effort' and fourteen exciting committees, with intriguing agendas which held the attention of the said youth, who now imbued the spirits of diplomats, politicians and even fictional characters who have left a lasting legacy on the popular television. With 650 + formally dressed, professionally behaved delegates, the grounds of Centre Point School, WN turned into a no man's land.



THE INCEPTION

The INCEPTION of CENMUN dates back to 2016, when Centre Point School Wardhaman Nagar initially partnered with Western India MUN and conducted it on the premises. Students of CPSWN were appointed as members of the organising committee. This is when the eagerness and curiosity rose in the mind of these young enthusiasts, when they started observing the internal work of hosting an MUN. From assigning of committee rooms to serving as volunteers on D-Day, they understood the thrill and responsibility of such an opportunity. It was after this event wrapped up that they realised they wanted CPS to have an MUN of its own. And thus, after countless rejections, disappointments and brainstorming, they presented us with 'CENMUN'. The first edition of CENMUN was organised in 2017. The 11 members of the secretariat, from classes 10, 11 and 12, were appointed as heads of different departments including Secretary General, Deputy Secretary General and the USGs. From getting invoices, to inviting delegates, arranging the logistics, food tasting and everything in between was effectuated by these 11 members along with the volunteers. These students were backed by the teacher guides, who themselves were initially unacquainted with the concept of organising such a prestigious conference. But they, along with the students, learnt through the process and supported and motivated the team all throughout. The VICE PRESIDENT of CENMUN still recalls how the team had strived to come up with the majestic logo of CENMUN, the tagline “#YouthisYou” and of course, building the CENMUN website right from scratch. They also aimed at aligning the objectives of the conference with the UN Sustainable Goals, which added to the benefits of the conference.



And thus all their efforts, as evident, turned successful. They remained victorious in making the first edition of CENMUN triumphant, with 300+ delegates in 10 committees. It was the efforts, sacrifices and dreams of these students that inspired the delegates to participate in such an intellectually stimulating event which shaped future world leaders and diplomats. This further motivated the juniors of CPSWN to take up this challenge and strive to continue this distinguished legacy, that is CENMUN. We feel pride in saying that since its inception in 2017 upto 2022, CENMUN is the largest MUN in Central India and will continue this journey until kingdom come. All of this turned into reality by 11 minds having one dream!

REVIEWING THE COMMITTEES...

DISARMAMENT AND INTERNATIONAL SECURITY COMMITTEE

AGENDA - De-escalating the Syrian Civil War

DAY 1: This committee saw debates on two recurring themes associated with the war: the humanitarian crises and the foreign interventions and the legitimacy of the same. The delegates across nations agreed on the losses of war, yet marred with the classic dislodging of the blame for the first movers in the crises: The Assad government, the foreign bipolarity of powers headed by the US and Russia respectively, and the various independent groups involved in the infighting. The delegates also discussed the legal grounds and the UN mandate to facilitate an international intervention for ceasefire and peacekeeping.



DAY 2 : The Moderated Caucus topic of "Legitimization of the Syrian Government" was very well covered by the delegates. The delegate of the Russian Federation, with the support of the delegate of the Syrian Arab Republic, certainly proved that the Syrian Government did not directly attack its citizens with chemical weapons and further explained that even though chemical weapons are present in Syria, they are not under the control of the government, thereby, trying to prove the Syrian government's legitimacy. It is quite evident that the peace efforts are being continued in Syria by a lot of countries including Russia, the USA, Turkey, and many more. However, with so many outside countries fuelling each of the extremist militia groups, it is clear that there is still no end in sight.

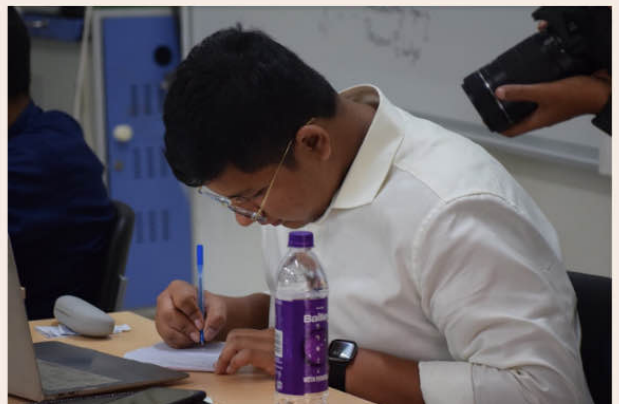


SPECIAL POLITICAL AND DECOLONISATION COMMITTEE

AGENDA - Assessing the Efforts to Address the Cyprus Question

DAY 1: The committee began with delegates specifying their diplomatic position with regard to the issue, followed by the moderated caucuses that discussed the history of Cyprus, the unfortunate genocide of 1974, the series of treaties signed between 1960-64, and the way ahead to reinstate political stability on the island. Interestingly, Turkey and Greece (the two opposing stakeholders in the issue) came together to eliminate the presence of the United Kingdom in the region, without any consultation with the Republic of Cyprus. This changed the course of the committee with the realignment of political incentives: Cyprus formed an alliance with the Russian Federation while its fierce opponent was the Greco-Turkish block.

DAY 2 : The committee started with GSL. Delegates talked about the mandate of SPECPOL and their stand on the UN Peacekeeping Mission for Cyprus. The delegate of Cyprus emphasized the importance and need of the United Nations. The committee discussed in length all the problems revolving around Cyprus. Delegates gave solutions to reunite the republic of Cyprus, Greece, and Turkey came together to eliminate the United Kingdom from Cyprus. China and Russia came together to draft the resolution and provide solutions for the agenda. The committee then tabled two resolutions that were not passed by the delegates. With 17 yes and 31 no, the resolution was not accepted.



UNITED NATIONS HUMAN RIGHTS COUNCIL

AGENDA - Discussing the Human Rights of People Involved in Prostitution and Sex Work

DAY 1: Human Rights Council was an interesting discussion to be a part of, wherein The representation of smaller nations was prominent and their voice was not overshadowed by those of their larger more developed counterparts. Some of the best justifications were made by delegates representing Korea and Bangladesh while representatives of stronger countries like China and the US were a little less engaging. Nonetheless the overall agenda of the committee was discussed well.



DAY 2: The committee primarily focussed on ideas of consent, within various religious paradigms and how consent is one of the primary rights violated in sex work. Furthermore, the committee focused on the new legal formulations that the UN could come up with in order to curb sex trafficking and ways in which prostitution could be recognized as a profession. The highlight of the sessions was that the delegate of Afghanistan claimed to have been feminist and would ensure the safety of women and deemed prostitution non-feministic. A series of questions ensue upon the delegate attacking the Taliban violence against women over the past two decades. The committee remained dynamic until it adjourned.

UNITED NATIONS SECURITY COUNCIL

Agenda - Reviewing the Progress of Joint Comprehensive Plan of Action

DAY 1: The committee began establishing what essential the JCPOA was, and what the shortcoming of the current JCPOA was. This was followed by a series of Presidential Statements: First by the United States of America - President Joe Biden announced a pact assuring the passing of a bill in the US Senate that binds them to the Nuclear Deal they come up with. Next, the Islamic Republic of Iran released a press note to withdraw its demand for whitelisting the Islamic Revolutionary Guard Corps - a branch of the Iranian Armed Forces. The committee also witnessed an alliance comprising Germany, Israel, France, the US, and the UK, which proposed a generalized framework (not limiting to Iran) with open membership to any country which wants to join.



DAY 2 : The USA said that there are a lot of problems in JCPOA. As every deal consists of a commitment and trust, the USA said that JCPOA is really bad at it and it has already broken it once. By continuing it Germany gave a neutral solution for it that JCPOA should spread across all the countries, if any country has some issues with them they can break the deal but still the one who doesn't would be continuing it so it will be fair enough for both of them. USA and Germany raised the controversial topic that Iran is supporting terrorism activities and cross-border terrorism. The USA also gave proof in the form of a document. Iran gave the answer for this by saying that we are using it for security and operation activities, we are not misusing it.



NORTH ATLANTIC TREATY ORGANISATION

Agenda - The Question of enlarging NATO and Ascertaining its consequences

DAY 1 : The committee broke down the agenda into digestible pieces in the form of moderated caucuses. The first was a discussion of article 5 of the NATO charter which provides that if a NATO Ally is the victim of an armed attack, each and every other member of the alliance will consider this act of violence as an armed attack against all its members and will take actions it deems necessary to assist the ally attacked. Next, they discussed the advantages and disadvantages for a country that wishes to join NATO, keeping in mind the ever-changing, dynamic world order.

DAY 2 : The committee resumed with more moderated caucuses. The delegates deliberated on the issues aa of the previous days. However, the dynamic had changed in the committee where smaller nations like Belarus claimed the existence of NATO is pointless, while countries like Lithuania favor its existence having stopped many wars. Its efficacy was also questioned with regard to counter-terrorism activities. By lunch, the delegates were confident that they had covered enough ground and were ready to draft a press release. There was some tension among blocs with regards to accommodating their demands but they resolved them amicably to come up with a press release that was agreed upon by all. The press release meted out details of the committee's findings, risk analysis of NATO expansion and then a mitigation plan for the same.



US SENATE

Agenda - Re-evaluation of the Gun Laws in the US

DAY 1: Agenda: Re-evaluation of the Gun Laws in the US

This committee addressed extremely pertinent issues ranging from topics like school and mass shootings to gun possession being an individual right to the impact of lenient gun laws, to firearm possession laws. The last moderated caucus was solution-driven. An important issue that was the highlight of the committee was the association of gun violence with the mental illnesses of the perpetrators, and the need to take mental illness and its consequences seriously. The delegates in favor of lenient gun laws have extremely rational arguments: the violation of article 2 of the US constitution, the sense of empowerment one may derive with the possession of a gun, and the need to educate citizens regarding safe possession of a gun.



DAY 2 : The committee witnessed a crisis today where an armed man was found outside the Whitehouse and the committee debated whether the armed man should be taken away from him. Further, the committee was also supposed to come up with solutions if the man were to take the laws into his own hands. These were discussed in the moderated caucuses which followed the discussion from the previous day on the issue of the 2nd amendment, individual right to gun procession, etc. the committee also successfully passed a draft resolution.



UNITED NATIONS COMMISSION ON THE STATUS OF WOMEN

Agenda - Reviewing Abortion Laws across Countries

DAY 1 : The committee started with the General Speakers List where countries specified the abortion laws prevalent in their legal system. The moderated caucuses focussed on women's health, bodily autonomy, legalization of abortion, and the socio-economic aspects of the same. The committee had a very sensitive agenda, and the delegates were extremely mature in handling the issue of this sort.

DAY 2 : The committee began with a moderated caucus on the various laws regarding abortion in various countries. Followed by a solution-driven moderated caucus that mentioned most points that were highlighted in the subsequent draft resolution.



GROUP OF 20 (G-20)

Agenda - Analyzing the renewed debt crisis of Third-World Countries

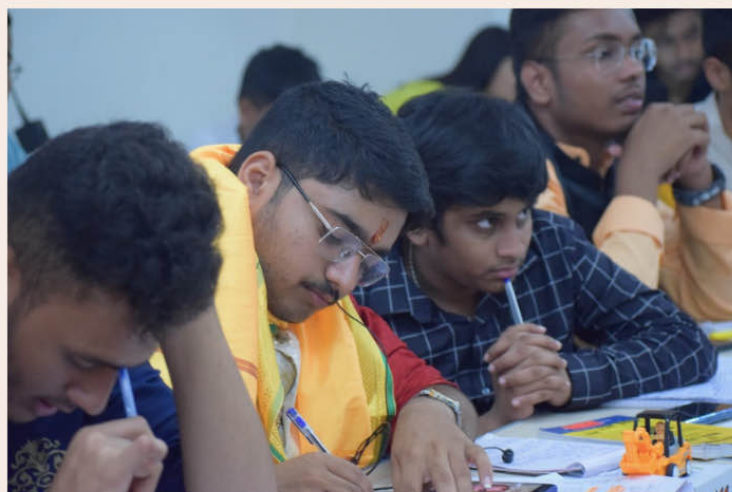
DAY 1 : The G20 on day 1 specifically addressed the problems of the third world countries where discussions were based on both microeconomic and macroeconomic variables. The issues being faced by households, businesses, & societies were intrinsically addressed. The overall economy of the country and the problems that they have faced in regard to trade, foreign exchange, and debt were given special emphasis. The committee was absorbed in discussing the role of the IMF, the World Bank as well as the influence of 19 countries as well as the European Union on the global scenario of trade and economics. Countries submitted their working papers, and position papers as well as their committee overviews at the end of the day which were then considered for finding out solutions to the given agenda on day 2.

DAY 2 : G20 discussed the ongoing debt crisis in various countries, with special emphasis on third-world countries. The committee was invested in finding the solution for the crisis at hand, after considering historical aspects of previous crises' as well as after due consideration of the social and political aspects. The current Sri Lankan Crisis was also examined under the microscope. The Russia-Ukraine War was also examined over the economical aspect and with due relevance to the European Union. The committee drafted a communique which failed due to the absence of unanimous votes of yes'.

ALL INDIA POLITICAL PARTIES MEET

Agenda - Discussion on the Places of Worship Act, 1991

DAY 1: The Committee firstly started off with opening statements from delegates on the agenda Places of Worship act, 1991. The committee could be broken down into two blocks, the United Progressive Alliance - which strongly supported the act as it maintained the secular fabric of India, was open to certain amendments to adapt to modern times, and firmly believed to protect worship places of the minorities. The second block was the National Democratic Alliance which strongly opposed the bill and called for the abolishment of the act as it wouldn't allow Hindus to reclaim their temples allegedly destroyed during the medieval era. The committee then discussed the Gyanvapi Mosque issue and Blasphemy related laws in India. Both parties agreed on stringent blasphemy laws in light of the recent Nupur Sharma controversy. Further, both parties clashed over the disputed Mosques and whether or not the Hindu community can reclaim their rights of having a temple on disputed land.





DAY 2 : The committee today deliberated on how media and external factors impact religious harmony in the country. All parties agreed that the media should not discuss those topics which are subjudice and should adhere to civilized debate instead of having fuming debates just to get more television ratings. The Committee then talked about solutions for the problems discussed on day1 NDA focussed on (a) Repealing the Law, (b) Formulation of Veer Savarkar Committee to formulate a new law to replace the places of worship act 1991, (c) Amending Communal Violence Act to take strict action against rioters, (d) Guidelines to media houses for Sensitive topics, (e) Guarantee of Peaceful Resolution of all disputed lands. The UPA focussed on (a) a Supreme court run committee to oversee such disputed properties (b) Defining blasphemy and hate speech again in a new bill. (c) Media training to spokespersons.

HISTORIC LOK SABHA (1951)

Agenda - Deliberating the possibility of codifying the Hindu Law

DAY 1: This committee went back in time and re-imagined the debates that took place while deliberating on the Hindu code bill in the year 1952. The committee split into people in favor, and in against the same. Arguments in favor of the codification ranged from the fact that the codification would help India achieve gender equality. Further, given the gruesome history of the partition and the codification of the Muslim personal laws, the Hindu laws would also bring in a sense of secularity in a newly independent India. Lastly, issues pertaining to the Hindu marriages were not yet appropriated and adjudicated and the bill would help bring in clarity in the same. Many delegates vehemently opposed the codification as they believed this was a stint in vote bank politics and India should rather Have a uniform civil code if equality and secularity is what it wanted to promote.



DAY 2 : Day 2 witnessed discussions that were solution-driven. Factions argue that the codification should take into account tribal and minority traditions. Another recommendation was that a discussion committee should be set up to address various issues pertaining to the agenda. Another faction still continued to argue in favor of the uniform code bill. In the question hour, the economic conditions of the country were critiqued and various solutions were provided in terms of rebuilding a newly independent India. The committee was also sent into a zero hour where there was an intense debate over the uniform code bill.



INDIAN PREMIER LEAGUE

Agenda - AUCTION

The IPL committee was a simulation of IPL auctions that happens every year in India. There were 16 teams participating with a budget of Rs. 100 crores. Teams could be a minimum of 13 players and a maximum of 15 players. The costliest buy on day 1 was George Butler (Rs. 26 crores). A total of 126 players went under the hammer on day one, out of which 40 remained unsold. Teams had very different bidding strategies with around 5 teams yielding 10 players each and almost around 10 teams reserved their budget available for the second day (a whopping amount of Rs. 70 crores each).



International Federation of Association Football (FIFA)

Agenda - AUCTION

This was a committee where there was an auction of the top football players across Europe, and European football clubs competed in the same. Predominantly, the auction was an English (Ascending) Auction and saw fierce bidding as the teams tried managing their resources and keeping costs economical. The committee also witnessed a crisis session where the owners of these top clubs were faced with the financial fair pay regulations by the FIFA Committee to maintain a secure, level playing field among the clubs and maintain the competitive ability for all clubs in the super league.



SUITS

Agenda - Continuous Crisis Committee

DAY 1 : This was a continuous crisis committee based on the famous American legal drama - Suits. The session started with the chair presenting the first crisis: 3 days into Mike Ross working for Pierson Hardman, Trevor Evans meets Rachel and spills beans about Mike not going to Harvard and Rachel then gives this info to her father, Robert Zane. The Crisis was then updated and solved when Mike Ross submitted his Diploma from Harvard Law School.



DAY 2 : New day, a new crisis. Starting off, the EB presented the third crisis in the committee, which was the plot of some episodes in season 4 episodes. The session then started with the PSL (Provincial Speakers List). The enthusiastic participants trying to overcome their mistakes on the first day added their names to the list.

With this, Day 2 of CENMUN 2022 came to an end. The MUN was declared closed in its virtual closing ceremony which also saw committees recognizing the best performing delegates in the same.
